



### EXAMINEE CONFIDENTIALITY AGREEMENT FOR ALL IPMA-HR TESTS

The term “IPMA-HR Test”, as used throughout this document, shall include all tests and testing materials published by IPMA-HR and identified in the IPMA-HR Test Catalogue published on an annual basis, as updated from time to time, and made available at [www.ipma-hr.org](http://www.ipma-hr.org).

I am aware that the IPMA-HR TEST is a confidential exam, and that its contents are being disclosed to me today in a limited context to permit me to test and for no other purpose. I understand that the IPMA-HR is the exclusive owner of all rights in the IPMA-HR TEST, for which it holds a series of registered copyrights under U.S. and international laws. I understand that I have no license or permission to copy, adapt or use any part of the IPMA-HR TEST. I understand that the registered copyrights for the IPMA-HR TEST include all IPMA-HR TEST questions, passages, graphics, incorrect responses and correct answers. I agree that disclosure, reconstruction and/or copying of the confidential contents of the IPMA-HR TEST would destroy the value and defeat the purpose of the IPMA-HR TEST, and irreparably harm the IPMA-HR. In addition, I understand and agree that the following confidential contents of the IPMA-HR TEST constitute trade secrets that I am bound to keep confidential indefinitely: IPMA-HR TEST topic selection, frequency and order, exam questions, passages, incorrect responses, correct answers and graphics. I understand and agree that protecting

and preserving the confidentiality and security of the IPMA-HR TEST ensures the validity of exam results and the integrity of the hiring and/or promotional process.

I agree that I will not discuss or share with anyone any information about the questions, incorrect responses, answers or any other content appearing on the IPMA-HR TEST after I take the exam. I agree that I will not discuss or disclose any IPMA-HR TEST content orally, in writing, on the Internet, or through any other means, nor will I assist anyone else in doing so. I further agree that I will not reconstruct any portion of the exam from memory—whether orally or in writing—for any purpose. I understand that discussing or disclosing IPMA-HR content, by any means, is a violation of this Examinee Agreement.

Just as I am not permitted to share information about exam content with anyone, I understand that I also am not permitted to possess, solicit, read, study from, or otherwise use confidential information about the IPMA-HR TEST during my own exam preparation. I certify that I have not engaged in such conduct prior to taking the exam and that I will not engage in such conduct during or after the exam. I also agree not to ask any other individual to disclose exam content to me or to seek out actual live, confidential exam content from any other source.
