The Warner W. Stockberger Achievement Award was established to honor the memory of Dr. Warner W. Stockberger, a pioneer and leader in federal personnel administration. Stockberger was the first director of personnel for the U.S. Department of Agriculture and served as the first president of the Society for Personnel Administration, a predecessor organization of IPMA-HR. The Stockberger Achievement Award is presented annually.

The purpose of the award is to recognize and honor a person in public or private life who has made an outstanding contribution toward the improvement of human resource management at any level of government.

All nominations will be considered as final entries and are **limited to 5 pages**. Supporting documents will not be considered. Materials submitted will not be returned. All nominations must be received by **June 4, 2018** via e-mail. The award will be presented during the 2018 International Training Conference & Expo in Phoenix, AZ on September 22-26, 2018.
